Why in the News?

The World Economic Forum (WEF) is holding its Annual Meeting from January 20 to 24, 2025, in Davos, Switzerland.

About the World Economic Forum (WEF)

The World Economic Forum (WEF) was established in 1971 as a not-for-profit foundation by German engineer and economist Klaus Schwab. Initially called the European Management Forum, it was later rebranded as WEF in 1987. The forum introduced the concept of stakeholder capitalism, emphasizing that businesses should serve not just shareholders but also employees, customers, and communities. WEF engages global leaders, policymakers, and businesses through dialogue, debate, and action-oriented commitments, aiming to build resilient, inclusive, and sustainable economies.

Background and Evolution

In 1973, the collapse of the Bretton Woods system and the Arab-Israeli War expanded WEF's focus from management to global economic and social issues.

By 1975, WEF introduced a membership system for the top 1,000 companies worldwide.

In 1987, it was officially renamed the World Economic Forum, broadening its scope to include global policy discussions.

In 2015, WEF was formally recognized as an international organization.

Funding

WEF is primarily funded by its corporate partners, which are global enterprises with annual revenues exceeding \$5 billion.

Serbia PM Resigns Amid Anti-Corruption Protests

Coringa and Adjoining Wetlands: A Prime Feeding Ground for Migratory Birds



Why in the News?

The Coringa Wildlife Sanctuary (CWS) and its adjoining wetlands in the Godavari estuary have emerged as a vital feeding habitat for 106 bird species, including nearly 70 migratory species. The findings were revealed during the Asian Waterbird Census-2025, conducted by the Bombay Natural History Society (BNHS) and the Wildlife Institute of India (WII). The survey recorded a remarkable count of 39,725 birds, underscoring the ecological significance of this region in Andhra Pradesh.

Diverse Avian Population: The census identified 106 species of birds, including 56 species of waders, in the Coringa and adjoining wetlands.

Threatened Species: Among the recorded species, three are classified as Endangered—Black-bellied tern (Sterna acuticauda), Great knot (Calidris tenuirostris), and Indian skimmer (Rynchops albicollis). The Common pochard (Aythya ferina) was identified as the only Vulnerable species, while 11 species fell under the Near Threatened category.

MIGRATORY PATTERNS: IVIOST MIGRATORY Species, such as the Great Knot, travel from Siberia, Mussia, China, and Mongolia to spend the winter in the Godavari estuary, which lies in the Asian Flyway Zone.

Prime Habitats: Bhairavapalem and Etimoga are two key winter destinations where large congregations of migratory birds have been observed. Notably, a Great knot tagged in Russia was sighted at Bhairavapalem after traveling approximately 7,500 km.

International Collaboration: The census data is being shared with global organizations studying migratory bird patterns to aid conservation efforts and track endangered species' movements.

Do You Know?

The Godavari estuary supports the feeding of nearly 90,000 birds annually, making it an ecologically significant region for avian biodiversity.

The Indian skimmer, one of the endangered species found in this area, is known for its unique feeding behavior, where it skims the water surface with its elongated lower beak.

The presence of a high diversity of migratory birds is a critical criterion for recognizing a wetland as a Ramsar Site of international importance.

Data Privacy Day 2025





Each year, on January 28, the world observes Data Privacy Day. The day highlights the significance of privacy and data protection. It all started in Europe, where it was observed earlier as Data Protection Day. In 2008, it was extended to the US and Canada, where it began to be observed as Data Privacy Day. On this day in 1981, the Convention 108, the first legally binding international treaty dealing with privacy and data protection, was signed. Today, Data Privacy Day is observed globally each year.

What is data?

In relation to data privacy, the term 'data' refers to personal or sensitive information about individuals that needs to be protected to maintain confidentiality, integrity, and security. This can include any data that identifies the person. The data can include personally identifiable information, such as name, contact details, email ID, date of birth or Aadhar details, PAN card number, passport details, etc. This can also include sensitive personal data such as health records, financial information, and biometric data. Data can also refer to behavioral data, such as online activities, geolocation data, or the device that the user is using, and can include the communication data, such as emails, messages, and call logs.

Why is data privacy important?

Cybersecurity expert and co-founder of The Organisation For Enlightening and Education (TOFEE), Tushar Sharma, said, "When personal data—like your name, address, online activities, or financial details—gets into the wrong hands, it can lead to identity theft, financial fraud, and even stalking or harassment."

Identity Protection: Personal data, if exposed, can be used to impersonate anyone, leading to unauthorized access to the date of birth, KYC documents, bank details, or even to the victim's social media profiles.

Financial Safety: Personal financial data, such as credit card details, online purchase history, and banking information, can be misused by cybercriminals/fraudsters to make fraudulent transactions.

Avoiding Discrimination: Data privacy ensures that sensitive information like your health status, race, or political beliefs isn't exploited or used against you, whether by employers, insurance companies, or even advertisers.

Personal Autonomy: It's about your right to control who has access to your information. If you don't have control over your data, companies, governments, or other entities can make decisions about you without your consent.

Cybersecurity: Protecting data privacy is also essential for preventing larger-scale cyberattacks. If individual data is compromised, it can lead to larger breaches affecting millions of people, compromising personal security on a wider scale.

Freedom from Surveillance: Data privacy also relates to personal freedom. If too much personal information is exposed, it could lead to a world where people feel constantly surveilled or manipulated by companies or governments.
